Listed below are the annual amounts for MEA retired membership dues for the 2019 tax year.

Dental, vision and health premiums are listed for those who paid benefit premiums by payroll deduction or manual payment. *Please note that the dental and vision premiums are separated by each Fiscal Year.* To calculate your total deductions for 2019 benefit premiums please combine each fiscal year's annual amount. (Example: If enrolled in the VSP Vision Member Only – first half of the year premiums were \$111.00 and the second half of the year premiums were \$111.00. The total benefit premiums paid for 2019 would be \$222.00) If you were enrolled in one of the benefits for a few months, you can divide the fiscal year's bi-annual premium by 6 to get the monthly premium.

If you were an active employee for any portion of 2019, please refer to MEA's website for your personalized breakdown ([www.sdmea.org](http://www.sdmea.org)). Retirees may also go to the website to get a personalized breakdown of the benefits you were enrolled in.
