Tentatively Agreed Upon Schedule

12:30 – 5:30 Monday (alternating with Saturday)
12:30 – 8:00 Tuesday
12:30 – 8:00 Wednesday
9:30 – 5:30 Thursday
9:30 – 5:30 Friday
9:30 – 2:30 Saturday (alternating with Monday)
CLOSED Sunday (except for branches with private funding)

We have attached a calendar depicting how this schedule will be implemented.

Key points are:

- Every full-time employee will enjoy two consecutive days off every week (Saturday/Sunday or Sunday/Monday).
 - o Please be aware that this schedule will entail staff working six consecutive days followed by a 2-day weekend, alternating with working four consecutive days followed by a 2-day weekend.
- This schedule is simple and consistent (open 3 days at 12:30 pm, then 3 days at 9:30 am), so will be easier for the public to remember.
- There will be no change from our current schedule to Tuesday-Saturday hours to the public; we will just add 5 hours to the public schedule on Mondays.

If the tentative agreement is not accepted, the schedule originally proposed by management will be implemented:

12:30 – 8:00 Tuesday
12:30 – 8:00 Wednesday
9:30 – 5:30 Thursday
12:30 – 5:30 Friday (alternating with Saturday)
9:30 – 2:30 Saturday (alternating with Friday)
